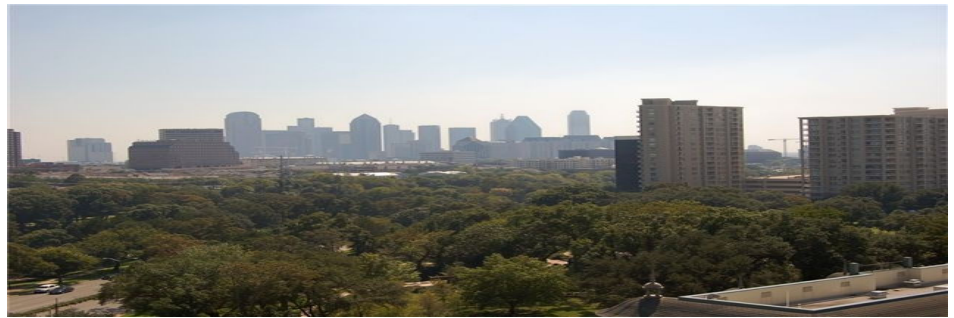

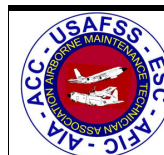

FROM THE AMTA VSO...

AMTA'ers, I am down to a little over two months until I retire as a County Veterans Service Officer here in Nebraska. I will still be available to assist you with questions or assistance in acquiring veterans benefits as your AMTA veteran's service officer. You will be able to contact me through my home email address of johnhurst@windstream.net, or by calling me at (402) 296-2805.

My message for you this newsletter concerns the importance of ensuring that you have filed a claim for your service-connected disabilities, if not for your sake, but for your spouse and/or any dependent children. You never know what service-connected injury or disease may cause us to meet our Maker. If a veteran dies directly from another problem caused by, or the result of, a service-connected disability his spouse will be entitled to receive compensation for the loss of her spouse due to the service-connected disability. The recent loss of another AMTA member due to his service-connected disability points out the importance of this benefit. Instead of suffering a complete loss of VA benefit income she will receive \$1067.00 a month for this year with a 2.3% COLA increase next year. She, and any eligible dependent children, could also be entitled to education and healthcare benefits. Many states have special benefits for disabled veterans and their spouse or widow, like homestead

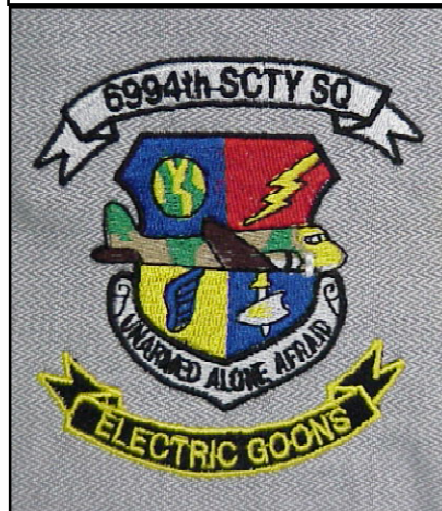

This is to give delinquent members a chance to renew their CHARTER MEMBERSHIP or to maintain current status without starting over. In the future a delinquent membership will result in the person being dropped from the membership roll 30 days after membership has expired. Members will be notified at least one month in advance of their membership expiration. Our goal is to keep members and gain more members especially the younger AMTs so the AMTA does not wither and die.
