New Laws Allow Retirees and Vets to Salute Flag

he National Defense Authorization Act of 2008 contained an amendment to allow un-uniformed service members, military RETIREES, and VETERANS to render a hand salute during the hoisting, lowering, or passing of the U.S. flag. The amendment did not address saluting the flag during the playing of the national anthem, pledge of allegiance, honors (i.e. Taps), or any other saluting situations. The Defense Authorization Act of 2009 has now added that the hand salute may be rendered during the playing of the national anthem by un-uniformed service members, military retirees, and veterans.
