#### VSO'S WORDS OF WISDOM

want to address this input to any of you that are being paid VA compensation at the 100% rate based in IU, individual employability. There has been a proposal by the staff of the Secretary of the VA to remove IU payment for those Veterans that are receiving Social Security payments. This would result in the compensation payment at the Veterans actual disability rating. If you fall into that possible situation and your disability has either worsened, or you have an additional service connected disability that could result in you receiving a new rating that would increase your combined rating to100% or improve your current rating, Consider submitting VA form 21-0966 "intent to file a claim" to the VA. This form will establish a new claim date from the date they get the form for one year without actually filing a claim at this time. If the VA does not change the IU benefit you can just not file a new claim and continue being paid at the 100% rate based on IU. If a change does occur you can file a new claim to try to improve your rating with a claim date back to the date of the intent form for up to one year. Visit a service officer if you have any questions.
